

Bucket List Whitetails Range rules and Procedures

At Bucket List Whitetails, we are committed to ensure that you have a great time and make lasting memories. We are also committed however, to ensuring that you have a safe experience. Here at the facility, we have some procedural rules that must be followed. The following list addresses safety guidelines that will be adhered to at all times:

- 1. All firearms must be unloaded at all times, unless in the hunting blind or at the direction of your guide. State law mandates that all firearms be unloaded and secured in a case when being transported in a motor vehicle or ATV. No loaded firearms will be permitted inside the lodge or any adjacent facility. Licensed concealed carry permit holders wishing to carry their own handguns may do so on a case-by-case basis. Notification must be made to staff if carrying concealed. No person that has been previously convicted of a felony may carry, use, or possess a firearm while at the facility.
- 2. Before going out to hunt in the preserve, all clients will shoot in their firearm/archery equipment at our facility range with their guide. This is to check for proper sighting/marksmanship to ensure a clean kill when harvesting your deer. Bucket List Whitetails operates under a "If you draw blood, you've bought it" principle. Any animal wounded and not recovered will be considered a harvest. It is our wish to make sure that our animals are harvested humanely and ethically. All clients will be required to watch a brief safety video before heading to the range. Hearing and eye protection are required and will be provided by us if you do not have your own.
- 3. Here at Bucket List, we strongly encourage you to have a good time. Even though alcohol consumption is allowed, there will be no handling of firearms while under the influence of an alcoholic beverage or other substance. Our guides or other staff representative reserve the right to refuse a hunt for that evening or morning if you appear to be under the influence. This is to ensure your safety and the safety of others while you are our guest.

- 4. A garment of "High-Visibility" colored safety gear must be worn when inside of the preserve. This item can be a cap, hat, jacket, or vest, etc., and must be visible from all sides. These items may be removed when in the blind, but when on foot, they must be worn.
- 5. All hunters will be required to sign a waiver of release prior to arrival or before participating in any hunting activities while staying at the facility. This includes non-hunting guests who accompany a hunter while at the facility. This release can be sent to you upon your request for information regarding booking a hunt at Bucket List Whitetails.
- 6. If at any time a check paid to Bucket List Whitetails is returned for insufficient funds, then interest and fees representing a 10% surcharge will be added to the unpaid balance upon receipt of notification by Bucket List Whitetails of there being insufficient funds. If full payment is not received within the next 30 days after such notification, then an additional 10% surcharge shall be added to the unpaid balance. After 60 days from notification, if the unpaid balance is not yet paid in full, then an additional 5% surcharge will be added monthly to the unpaid balance until the balance is paid in full.
- 7. Any guide tips paid via check or cash, will be paid directly to the hunt guide. Checks to hunt guides shall **not** be made to Bucket List Whitetails, and no guide tips will be added to the Bucket List Whitetails final payment by check or credit card.
- 8. Any lewd act, as determined in the sole discretion of Bucket List Whitetails management, will result in a forfeiture of a deposit (or deposits) and the person(s) shall be immediately required to vacate the Bucket List Whitetails premises, or the premises of any associated person or company.
